Verbal Feedback

- I have experience with a private organization in the past who did a great deal of research in waste to energy using thermotechnology that does not have emissions or any waste. And it's just lost on me how all these years later, we're still talking about the same things in this country. One obstacle that we had initially was that this is already a proven technology that's in Europe and France and Japan. They have it inside of communities, it's so clean, it's not tucked away in some countryside somewhere. But, we had to have the legislation updated, to include smelting rather than, the technology kept getting, pigeonholed into an emissions releasing technology, which it's not. Some of our customers were, Puerto Rico, because they're an Islander state, LA County and LA City, and we were talking to several, cities along the East Coast as well. The thing is that there's a tipping point, there's a tipping fee, rather, issue that seems to be blocking with the pers... with private industry with regards to... to the... the big money-making business that waste is in our country. And I would like to see some, uncoupling of some of these old, archaic processes that we've been using. And it just seems like we still can't get past GO, so I'm... I'm just going to listen, but, you know, I've... I've got some information that I can give you at the end if somebody wants to go and take a look.
- I live out at Lake Monticello, and I'm an older person who's been through a lot of workshops and a lot of environmental actions, promotions, and it just is... recycling seems like it should be something we've got onto. But, I'm really disappointed in Lake Monticello. I'm really... I was surprised to see that Fluvanna County, or I guess our private collector, does not have to report. And how is that even possible? How can you do it regional plan and talk about Fluvanna County or the population center here without having data. And I took that survey, and that's what made me interested in joining this workshop. Yeah, the survey, I had a lot of input about what goes on here, and that's really all I know about, this neighborhood. There are directions on the cans, and then you see other stuff go in the cans, and then when I ask the neighborhood what actually is allowed to go in the cans, it's another whole list that doesn't match. And it all gets picked up anyway. It doesn't matter. People have, fluorescent tube lights in their recycling bin, and you walk past it later, and it's emptied for them. There's so much else going on right now, I haven't really made any

campaign about it. But it just seems like this is basic stuff. We should be able to get this right, and I think it needs... It needs enforcement. It needs people to be fined. It needs them to be told; your trash doesn't get picked up if you don't do it right. You know, no more of just letting people do whatever they feel like should be the way to do it, or what makes it easy for them. With no repercussions, and... it gives the message that it really does not matter. It's not important. So, that's my input.

- Just in my experience with the SMART goals concept. Continually improve is not an achievable goal. There must be, and maybe this is more of your broad goals, and maybe you have somewhere else where it's more specific, so that might be what I'm missing. But, instead, you would set a measurable outcome. So, like, if... if we have not reached... I see that in a number of our past plans, we have set 25% as the goal, and we have not reached that, so we might need to figure out what do we need to do to make it truly reached, you know, or is our goal 35%, or... but yeah, just specificity and measurable outcomes. Yeah, continually improve is not really an achievable outcome.
- For resource and recovery waste goal 2: Comply with State and Federal regulations, it seems like that that's a moving target, depending on who's in charge. In, in, you know, by state or city, and it, it doesn't, you know, a lot of, a lot of, municipalities are not on the same page, at all. And again, I think a lot of this is just driven by, you know, the private sectors, but you know, not to beat a dead horse, but with the... with the Tenasco thing that's going on, you know, I mean, that's a gasification plant, but that's not really going to... I mean, if we're going to, you know, if they're going to do that sort of a thing, why not look at something that can do that, offer gas as a... as a byproduct of also processing waste? I mean, and maybe this is a new concept for some of those that are listening to the call, but this has been something that's been out there for such a long time, and we're just not... I mean, it's like we're just not... we're being faked about it. And I... and I think it's... it's not because we don't understand it, I think it's because of the industries that are already here and established. And they don't want to give up the turf. But, again, in order to know what our goals are. Those targets for emissions and whatever, they changed... I mean, they cha... they changed in Virginia. Which made some of these plants be able to say, oh, we're within regulation now. You know, we're within regulation. So that kind of makes it... makes you feel that, oh, well, then we're safe. But that's not necessarily the truth. That's not exactly a fair assumption. But, but I just, I guess I just want to say is that, are we keeping up with, the changes of the regulations. Sometimes they, you know, have a high bar, and then someone else comes into

office, and that bar is lowered. And I guess, are we, are we a voice to... to affect that, to be more consistent with, with the needs of how we process our waste responsibly. And, do we have a representative that is at that table when those decisions are being made? That's... that's kind of... All I wanted to say about that.

- A request for information for other, other, processes, and then the same old, things that we're using now. Can we join other regions? I mean, this... Couple county, region. Doesn't have to recreate, can we join with larger populations in you know, those, those kind of... big needs.
- Trying to make a goal for, you know, reducing the waste that we basically buy and then throw out. I mean, how... I don't understand how a group would decide to do that when our You know, profit-driven Economy allows product creators to do whatever they want. I mean, we don't choose to have things packaged in plastic, and if you... you can choose an alternative and you care, you do that. We've been doing that for...Decades. And more stuff comes out in package, in, you know, over-packaged all the time, still. There's no... cost to them. I mean, the cost has to go to them. They have to bear a burden, or they're not going to change it, and we Change it from our end. So, I, you know, it's been years since I worked in this sector of waste to energy, but, since I've relocated here to Lake Monticello and have attended some of the Tenaska gas, project meetings, I've just become, you know, I've had a resurgence of interest in this field. So, I'm just trying to figure out where we can get data. I mean, you know, AI, maybe, even. I mean, I don't know, somewhere, somewhere we should be able to find this data. - I suspect that with, storm damage, the residual waste that's created from that Probably, in many cases, gets shipped out of the state, to wood pulp factories or other types of things like that, but other waste also gets shipped out to other states and winds up in other landfills, outside of a particular... state. So...I'm just trying to connect the dots, and it would be helpful if somebody from... and I'm sure, you know, maybe some of it is proprietary information, and they wouldn't want to share, but I know that, for example, California, in 2009, they were recycling over 50% Of their waste, and they were still filled up at the landfills and transporting their waste to the Middle Atlantic states for processing in other states. Do you ever work with, anybody... any representatives from the Southern Law Center? Because I think they track some of that information on where and how waste moves in the state.

- So, I, you know, it's been years since I worked in this sector of waste to energy, but, since I've relocated here to Lake Monticello and have attended some of the Tenaska gas, project meetings, I've just become, you know, I've had a resurgence of interest in this field. So, I'm just trying to figure out where we can get data. I mean, you know, AI, maybe, even. I mean, I don't know, somewhere, somewhere we should be able to find this data. - Well, I was going to say that the jobs that might be, created for a Thermo Select type of It would be mostly in the infrastructure piece of it, There's not a whole lot of regular staff once the project is up and running. Maybe, you know, 20, 25. if that answers your RG2... RG2, or contributes to your RG2? Jobs, could this also be tied to jobs, economic development. But with the, you know, with the data centers needing more energy, and them screaming for more power, and it's, you know, it's a topic that all of us are mumbling about, the waste-to-energy thing just makes sense to me. But, and there's no emissions or pollution or any of that. It's just... it produces gas that can be captured and reused and turned into electricity, and it also... what... Of the solids that are left over, the residual, it is aggregate that gets reused as roads, as part of the material that they, do roads, make roads with. So, it's... it's just an absolutely incredible process, technology, but, yeah, so I... there would be jobs initially, like I said, for the infrastructure, but not, A whole lot of jobs after.
- I just don't hear anything about... recycling... I guess the sense is that people... it's... it's, settled. Like, people recycle, whether it makes them feel good, or whether it saves them money with their trash disposal fees, and that's that. Like, it's not part of a serious... part of our community. You know, that that the garbage... dealing with garbage is a, serious concern of any... of anyone's, really. It just seems like it's a minor detail not to be... Really given too much thought to.
- I was just going to say that, you know, gosh, you know, recycling is supposed to be a feel-good thing, right? You know, you're doing your part and that sort of thing. But after being in the industry that I was in, it was a... it was just a mind blow to find out that recycling uses a lot of energy. A lot of energy, and then it's resold to companies, and they make things out of recycled materials, and then they can put a label on their product and say, oh, you know, we're being sustainable. And so, you know, it's... it's not their fault. I mean, they're... everybody has sold that story, you know, but... But recycling, I think, was really developed in large part, too, because it... it

makes their... there's more room in the landfills then, you know? There's... or there's less landfills, or whatever, but that hasn't been the case, as the you know, I mean, California is just one example, but there's lots of other states that are... that are in the same situation, where they're recycling more than 50%, and they're still filling their landfills. But, you know, I... you know, people would think I was being Silly to think that recycling isn't beneficial. And I... and I think there definitely is a place for it, but I think that, it's using up a lot of energy to recycle also, to process recycling, and so I would just, again, I just keep circling back, is why don't we just get it all done in one fell swoop? You know, turn it into something we can use, like energy and, you know... Materials for our road infrastructure. But, so if anybody's interested, I know there's...some... some of these, like I said in the beginning, are in Japan and France, and... the technology was developed in Switzerland, and, so, yeah, it's a... It's a thing, and it's just a shame that we haven't been incorporating it more than we... We just don't at all. Do it here, so it's just unfortunate.

- If the % is for the region, it cannot be known if private collectors don't report. So planning goal 1 would need to be - collecting valid information to measure it at all
- Waste to Energy - I lived in Spokane WA for many years, and it was a good system, other than the occasional illegal activities = so again enforcement is key
- Is there any discussion yet about the concentration of poisons in plastics occurring in plastic recycling? These pellets created are loaded with pfas and nanoplastics, then made into polyester baby clothes. Gross.
- Producer pays is the watch word for pfas in drinking water even at the EPA, seems like an easy jump to solid waste with the right leadership
- Historically in Virginia, business FIRST has been the rule. This means protecting the hauler businesses has been the rule from the general assembly.
- Another scary topic is sewage sludge, another form of waste. which carries pharma, pfas, heavy metals. When localities discuss banning or regulating land spread of sludge, they are told "where will we put the sewage treatment by products?" Blue Plains in DC has a huge investment in waste to energy, but the smaller treatment plants have no money for it. Trump cancelled a 40M\$ grant to Blue Plains to complete their project.

- There is interstate activity. Now MD has banned sludge spreading, so lots more is coming into the northern neck. Gen Assembly has bills to regulate and perhaps to authorize localities to do more. My fear is that all this work and reports goes on the shelf in DC and Richmond, never to be seen again.
- Citizens in Crozet have wanted a recycling center for 20 years. 14k residents could have an impact
- A goal suggestion for stimulating demand - prioritize business approvals for those that make use of waste stream - instead of data centers, tenaska, etc
- When I was little in the 50s, we had a bottle bill in Virginia. Kids made pin money picking up bottles on the roadsides. I have been trying to get this back to the legislature for 30 years

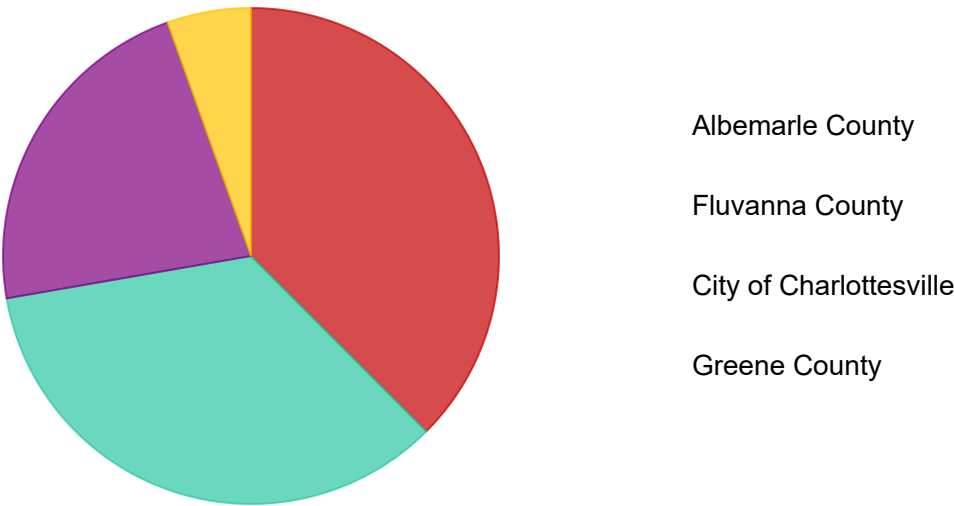

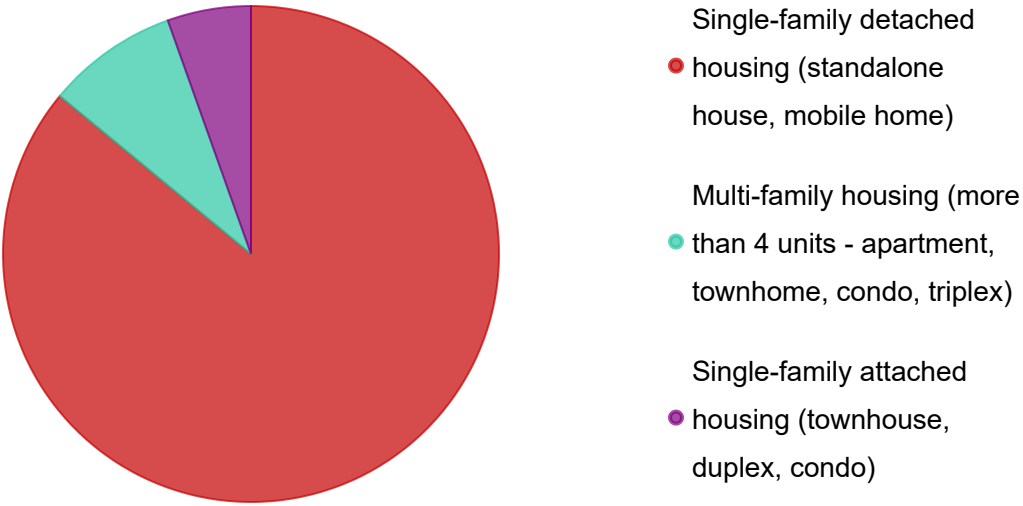
Where do you live?

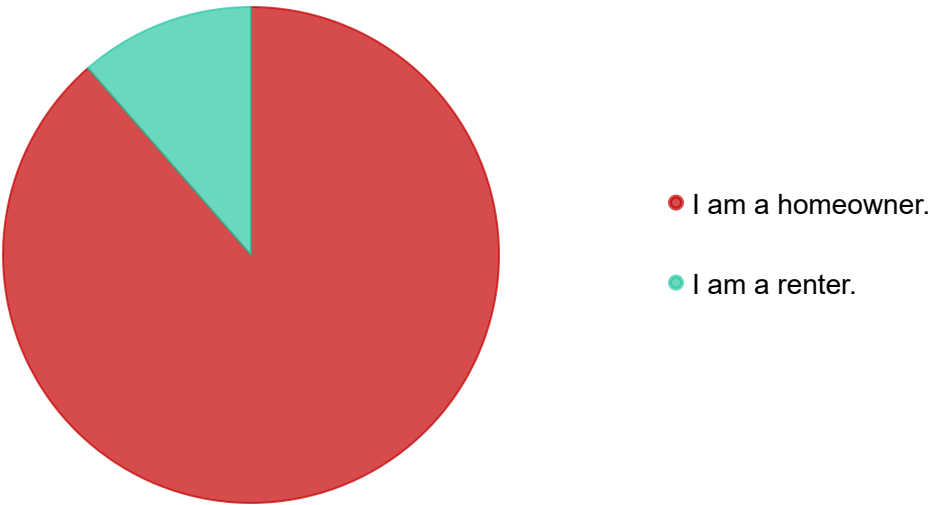
What type of housing do you live in?

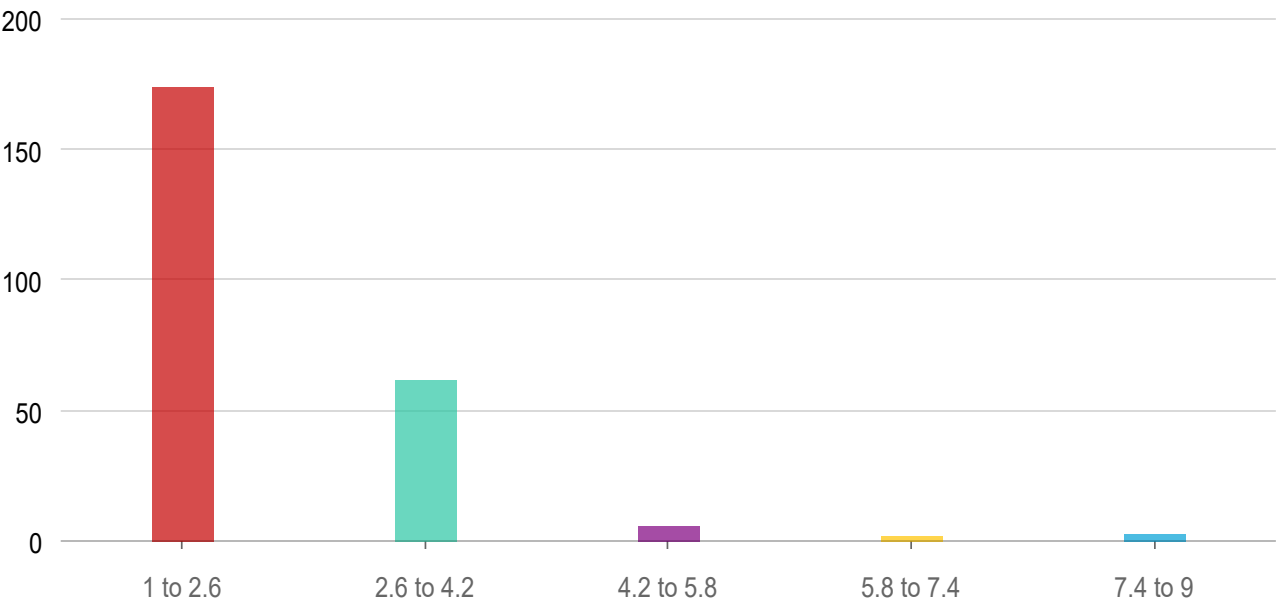
Do you own or rent your home?

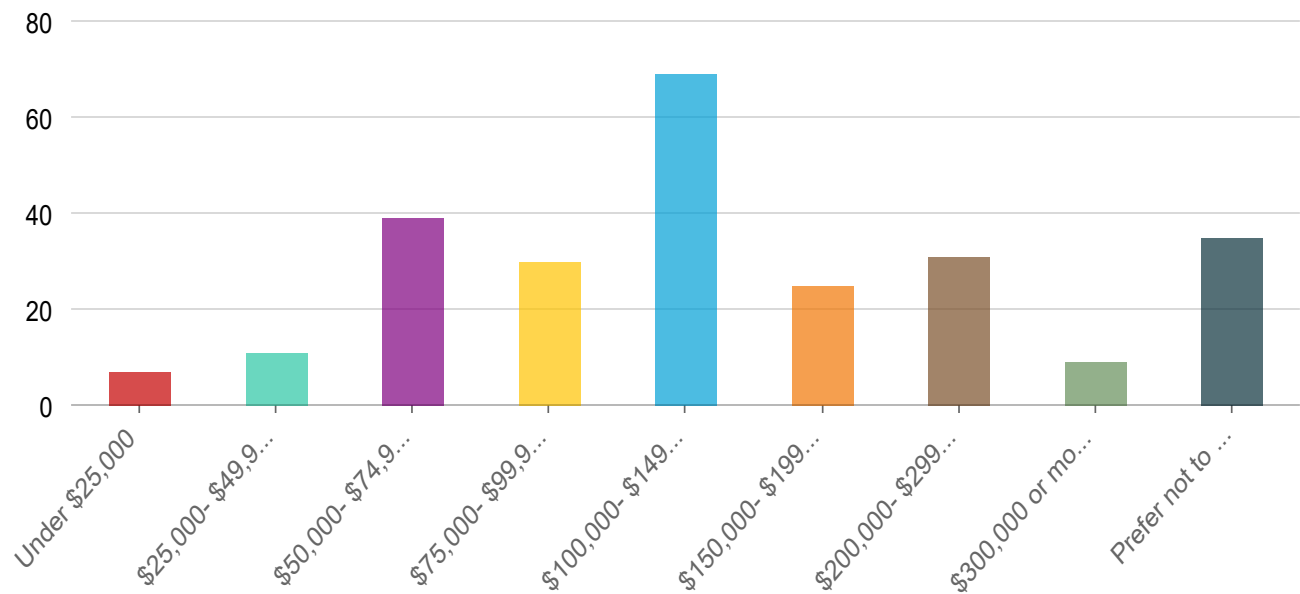
o Including yourself, how many people live in your home?

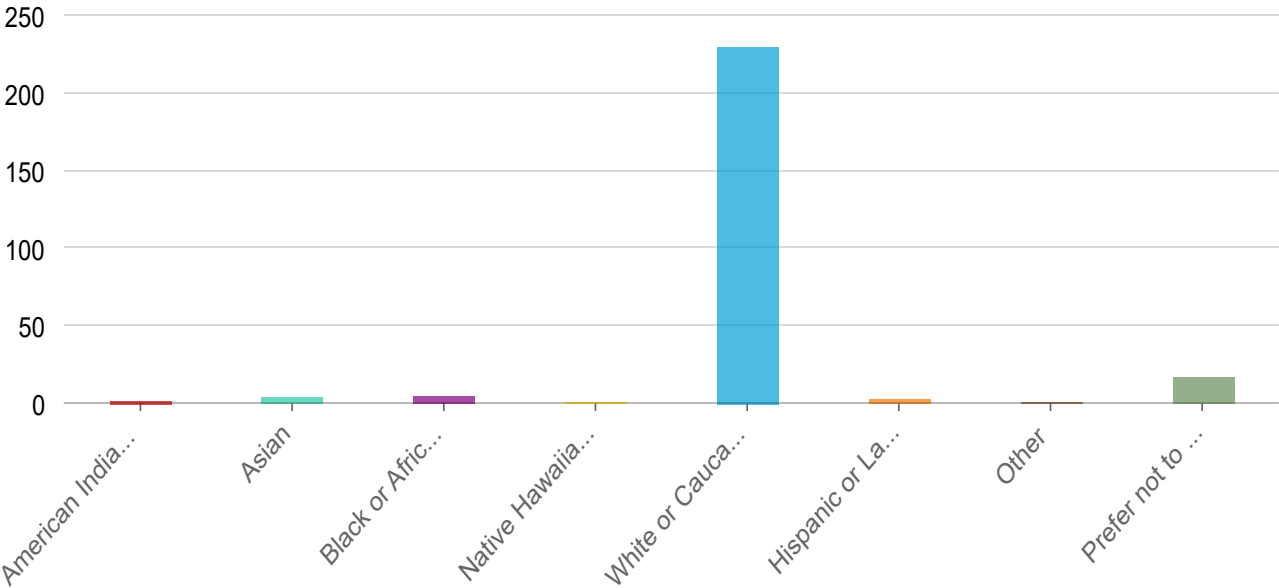
o What is your annual household income?

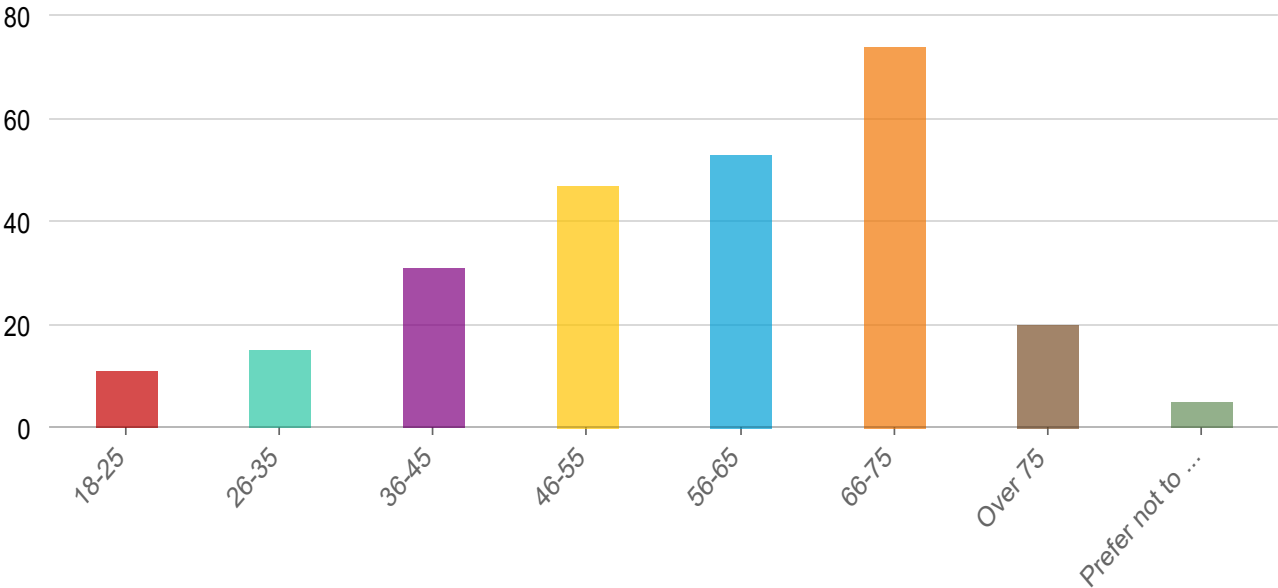
What race or ethnicity best describes you?

What is your age?



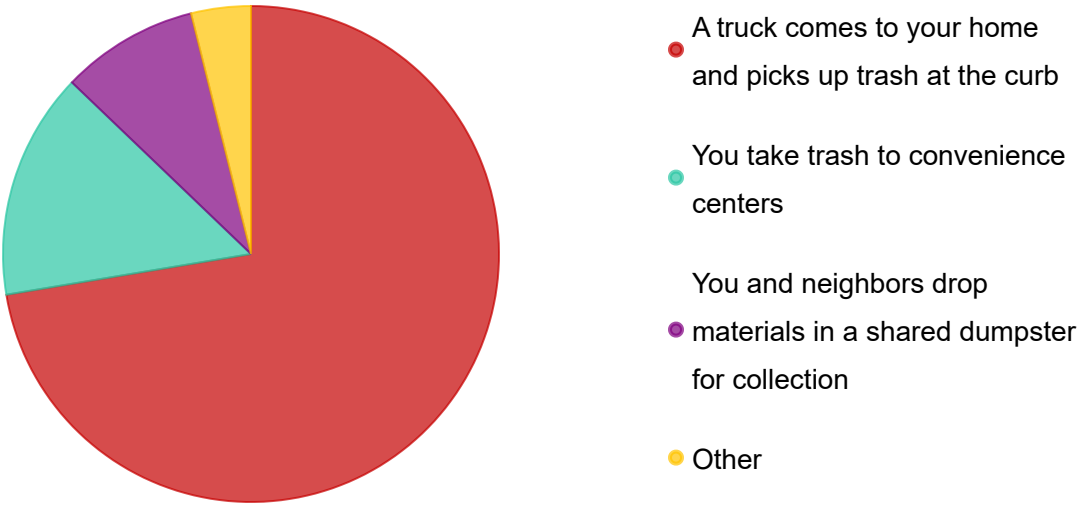

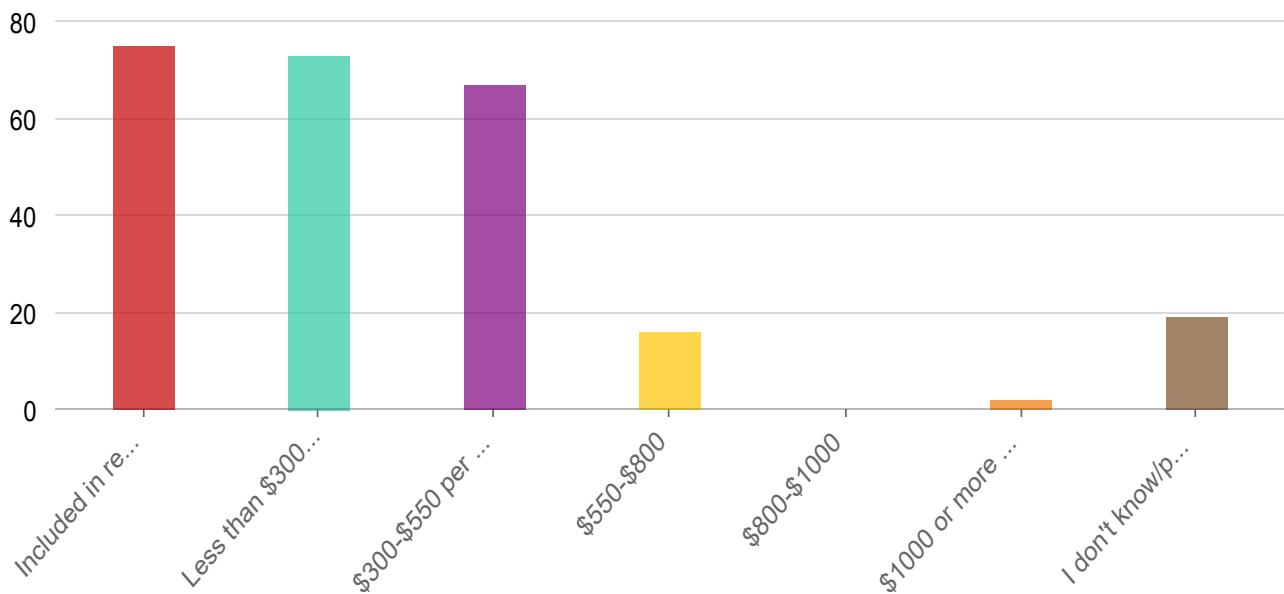

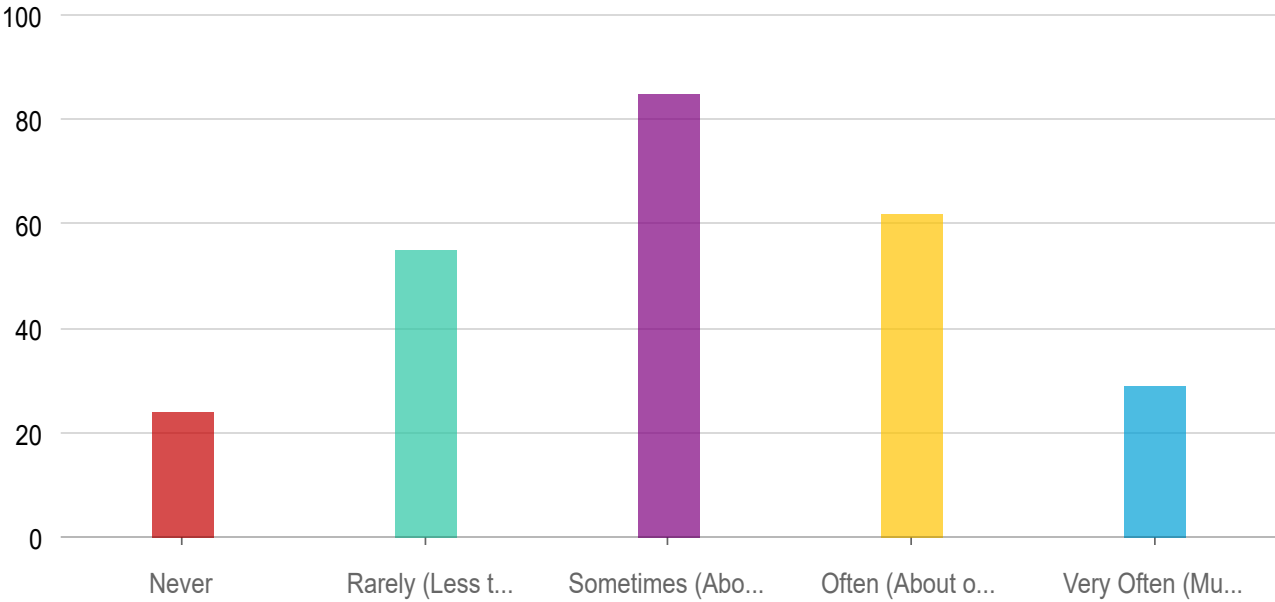
○ ○ How much do you currently pay each year for waste collection services?

○ ○ How frequently do you choose not to purchase a product primarily...

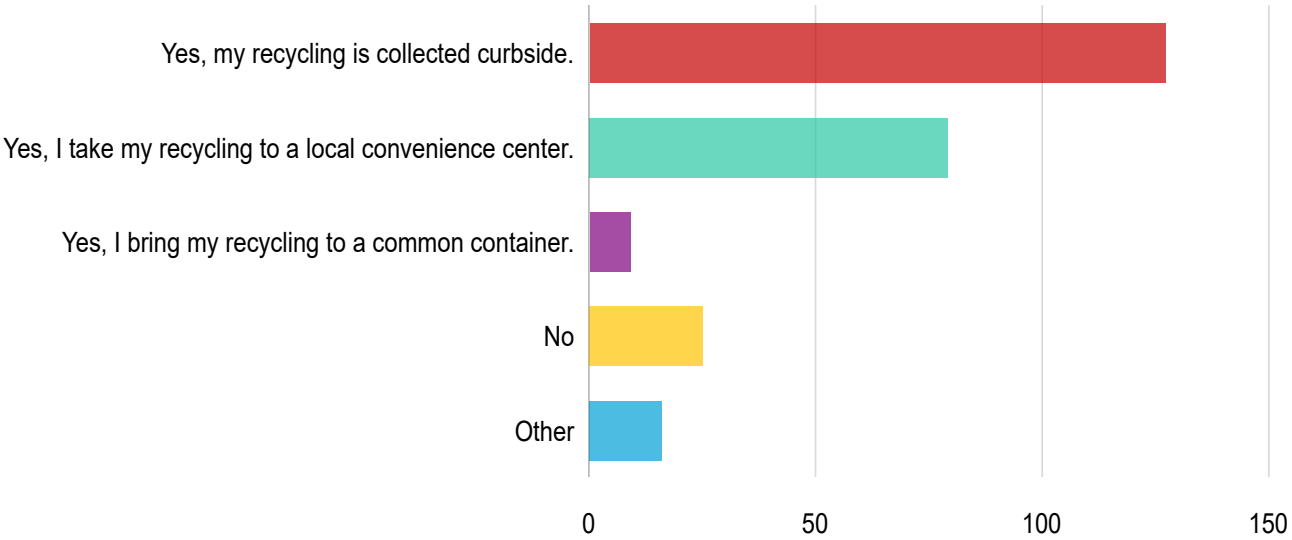

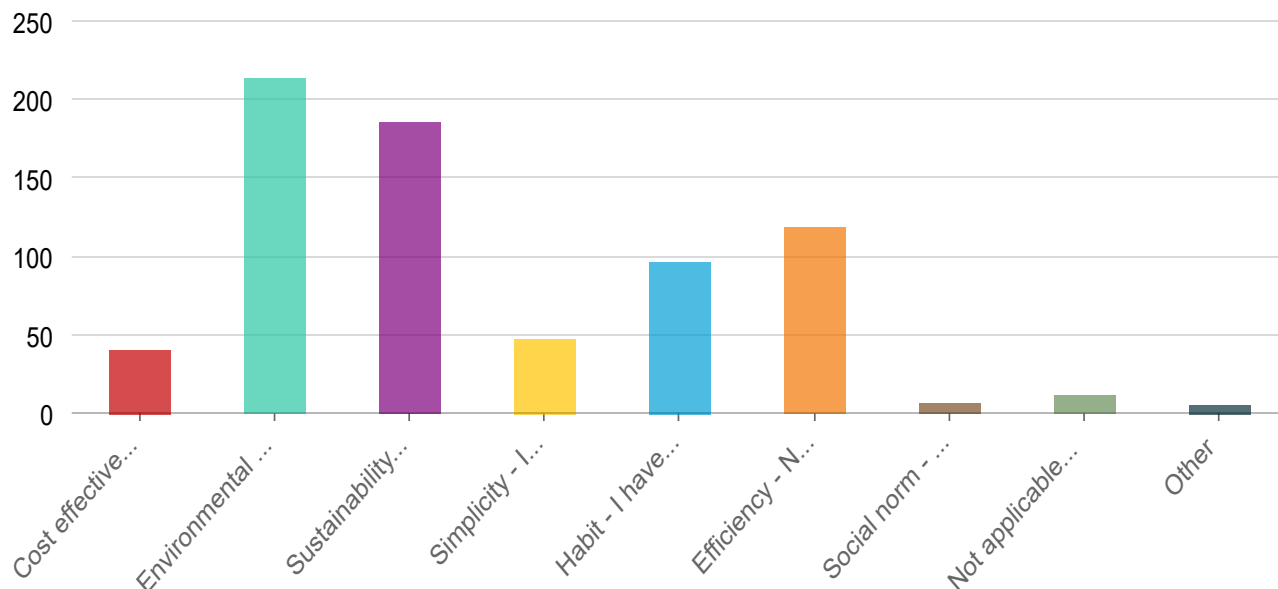

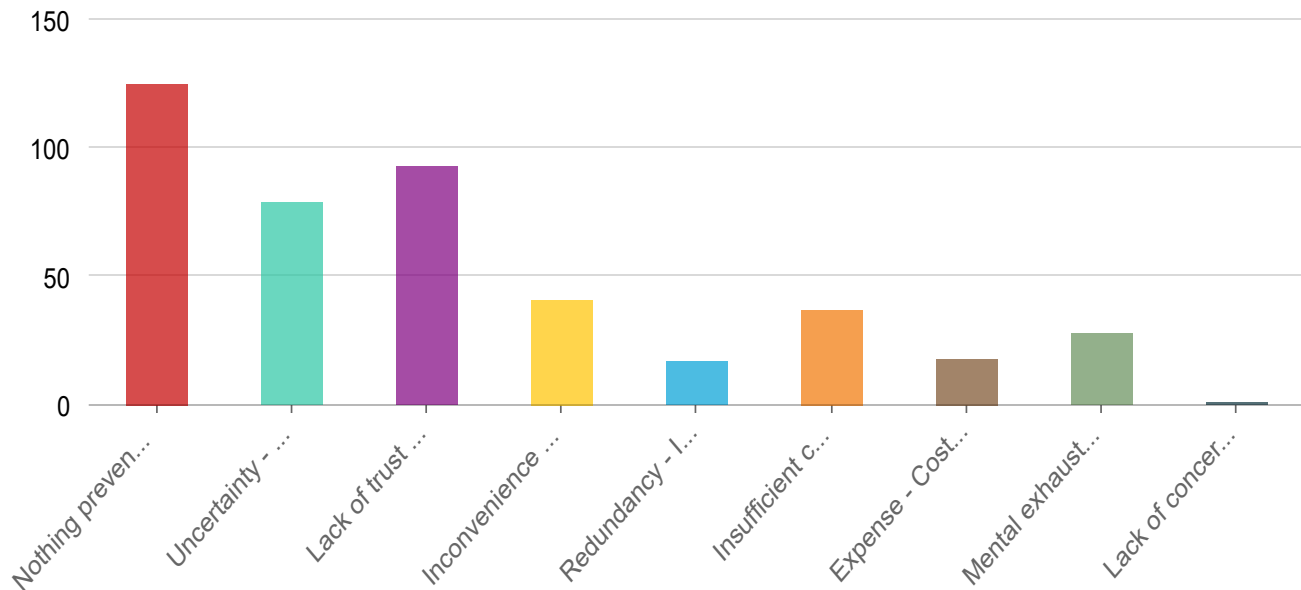

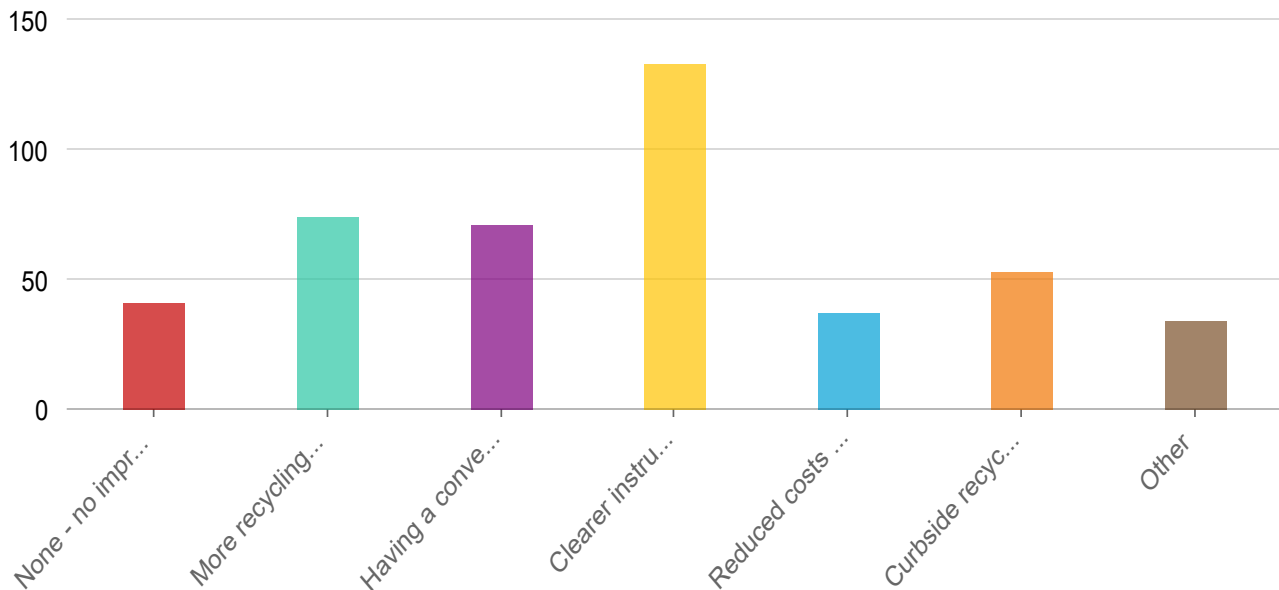

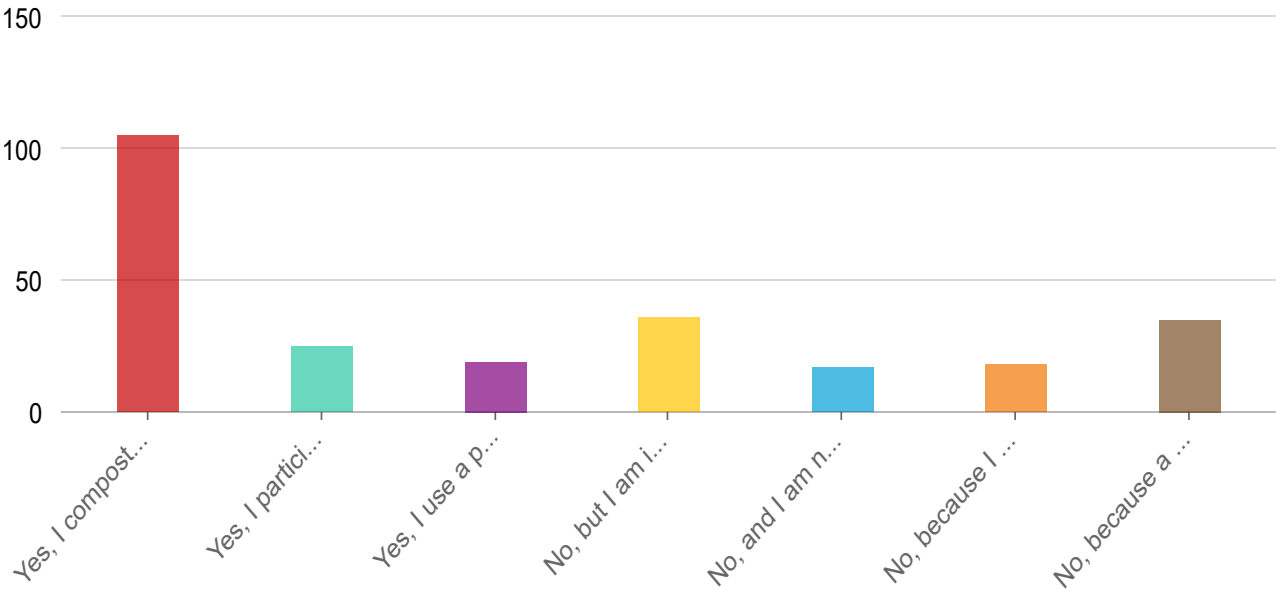

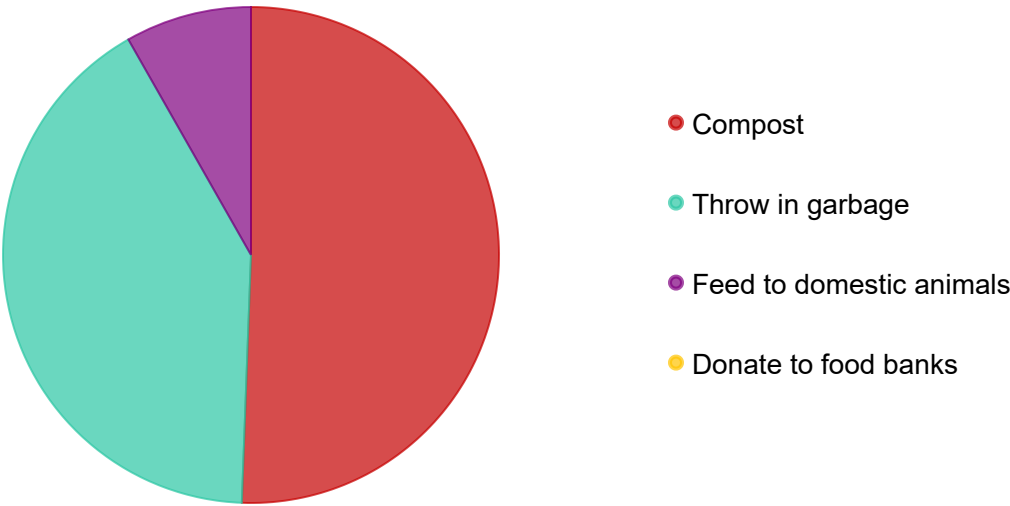

What do you do with food scraps that you don't consume?

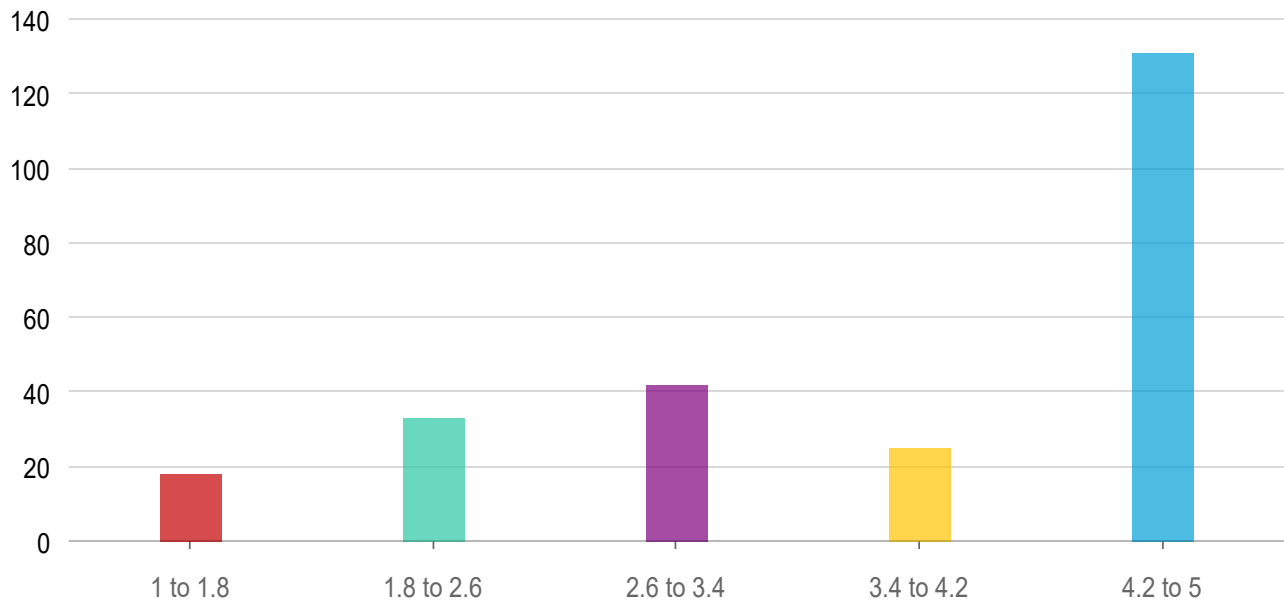

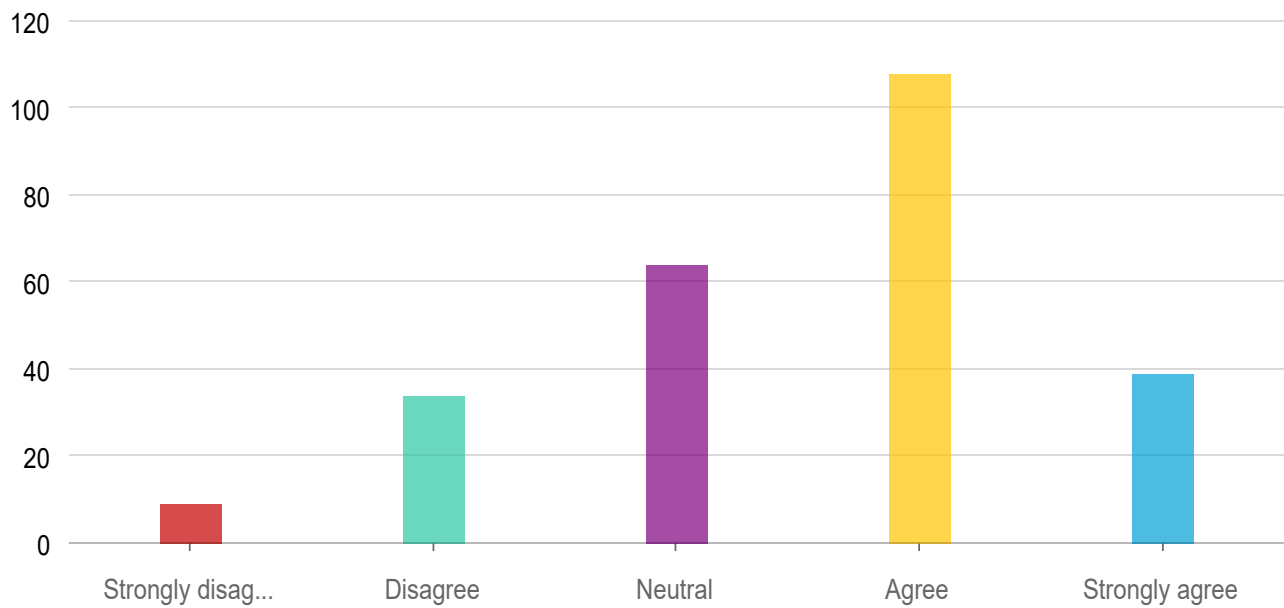

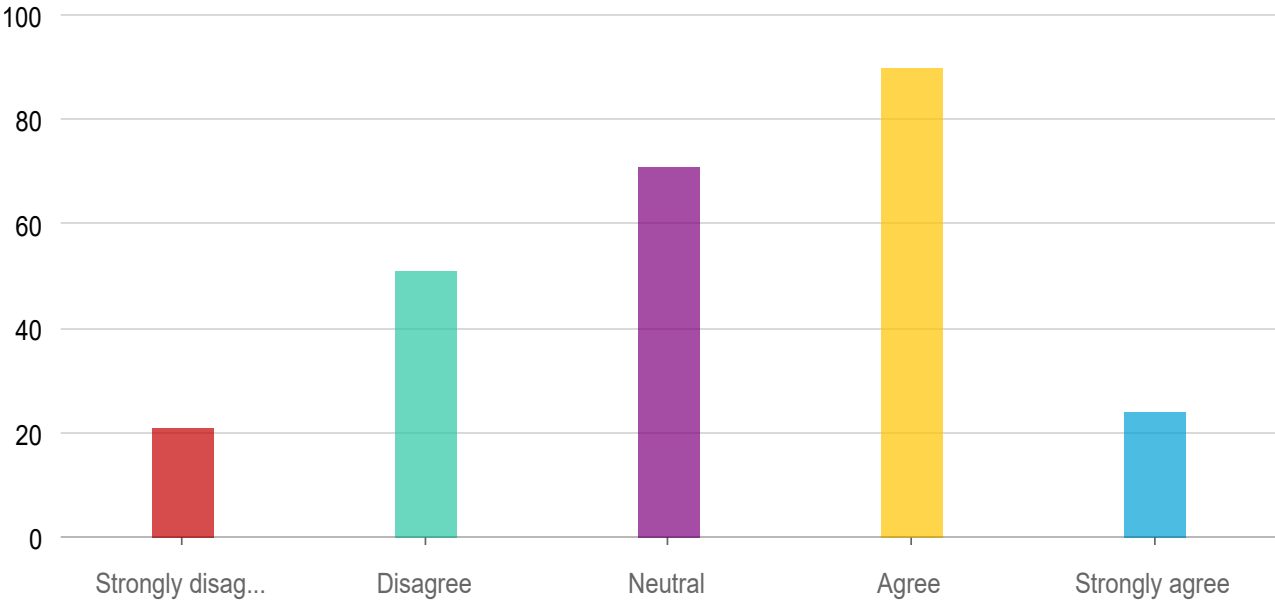

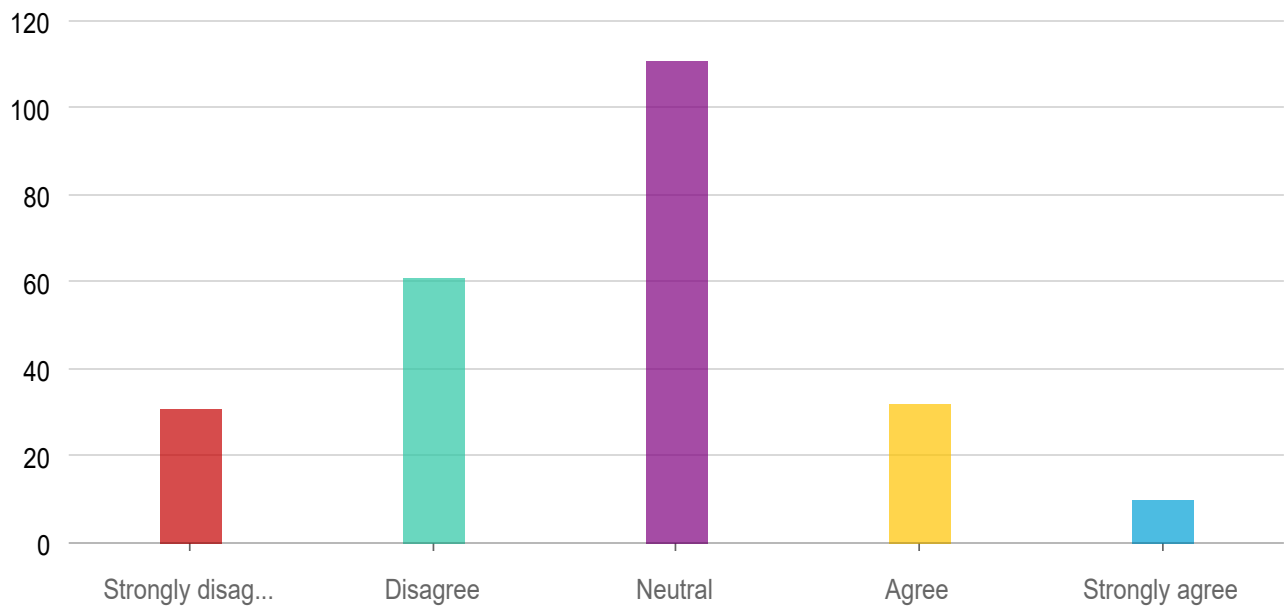

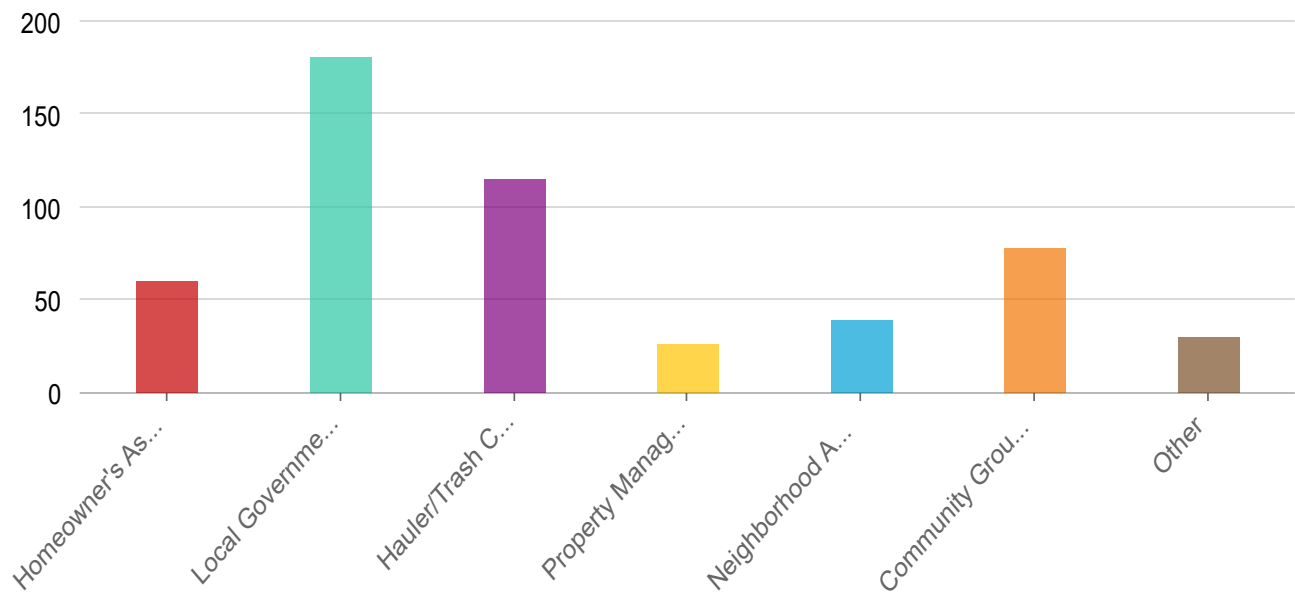

While we are doing better in Charlottesville/Albemarle than many localities in terms of recycling, composting, and solid waste management, we can still improve! Black Bear does a terrific job with composting. We are able to compost so much with them that we produce very little trash.	1
When I had an office job in Charlottesville, I ran the office composting system. It was as simple as putting a compost bucket near every coffee machine, all of which I took home daily to empty and wash. I did have to pick out bits of plastic sometimes (plastic tea bags -- horrible!) but it was well worth it to get all of that material for my garden. If you can make people feel good about doing something & make it simple and easy to access, maybe more would compost and recycle. Or pay people to recycle and compost -- in some New England states you can return bottles for cash.
